## Chapter 1 SUSTAINABLE USE OF RESOURCES

#### A. Sustainability

1) a) Promote productive equilibrium between people and the environment by bringing population and consumption into balance with the resource base.

#### C. Population

1) Because of the environmental impacts of population growth and movement on finite natural resources, the League urges governments and private agencies to conduct scientific research and encourage polices, attitudes, social standards, and programs that will-through voluntary actions consistent with human rights and individual conscience-bring about the stabilization of human population. Government and private efforts should include but not be limited to:

a) Developing a national policy on population and natural resources that integrates population, natural resources, and technology.

b) Incorporating sustainable development principles in U.S. policies, both foreign and domestic.

c) Developing goals for stabilizing populations that incorporate the principles of sustainable economic development, social equity, education, basic and reproductive health care and environmental conservation.

d) Providing age appropriate education for people of all ages, especially students, on human development and the relationship between human populations and the environment.

e) Supporting efforts to stabilize population through family planning and by promoting equality between men and women.

2) The League supports the right of all persons to freely decide the number and spacing of their children consistent with the dictates of individual conscience and accepted medical practice.

Scholarship Committee - Donations continue to come in. Jim Arnold motioned that we use the income from the silent auction for Scholarship. Roger Williams seconded. Passed unanimously.

Rentals – Rentals for 2011 down from 42 to 36 decreasing income by ~\$1200 from last year. We do have 14 reservations for 2012 already so it could be a good year.



## Holiday Party 2012 Featured program: *Island Treasure*

Produced in the 1950s, *Island Treasure* outlines the history of Banfill Island (aka Casey's Island aka Breck's Island) from prehistory through the logging days and up to more recent times when Dr. Breckenridge built his home opposite the Island in 1940. As a pioneer in filming nature subjects he necessarily spent many hours up close and personal, studying the wildlife there over the next 56 years.

Breck used this film for several years on his lecture tours, but he always narrated it live, so it had no soundtrack until a recording of his voice was found at the Bell Museum. Thanks to modern technology, Kyle Grindberg at the Museum, aided by Barbara Franklin as a consultant, synchronized the narration with the film, and Dell Eriksson and Barb recreated some of the animated portions that Breck had cut because he felt the film was too long, and the animation too amateurish!

The Breckenridge Chapter is proud and pleased to have not only the legacy of owning the Island, purchased from the University of Minnesota for \$100 in 1980, but also the legacy of this visual record. We are glad that the Island remains in its natural state so that others may see it as Breck did. Come and enjoy a visit to "Breck's Island."

DVDs of the film will be available at the Holiday Party or from the Bell Museum for a suggested donation of \$25 to cover costs of production.

## The Mighty Oak Tree

Every Mighty Oak was once a little nut that stood its ground. A mature Oak Tree is tall and proud. It has weathered many challenges yet still clings to life. It has survived harsh winters, wars, famines, droughts, wildfires, storms, and lightning strikes. But will it survive the bulldozer?

The largest certified oak tree on record is the more than 1,500-year-old "Seven Sisters Oak" in Mandeville, Louisiana with a circumference of 38-feet and a 150-foot crown spread. The Seven Sisters survived a near direct hit from Hurricane Katrina in 2005.



Much of the area around the Breckenridge Chapter and the northwest suburbs was once oak savannah. Concerned chapter members have explored and examined several remnant portions of oak savannah within the city limits of Champlin and Brooklyn Park. Both cities are aware of these remnant oak savannahs. Some of the beautiful oak trees along highway 169 were saved from development by chapter member Dick Brown.
