Breckenridge Autobiography

Many of you are aware that Walter Breckenridge finished a very rough draft of his autobiography over 10 years ago. His daughter, Barbara, then began processing and editing the variety of materials Breck had used to record his thoughts: Handwriting, typing and word processing. More recently Barb was assisted in the editing by John Moriarty who has considerable experience in book publishing. John also added a wonderful appendix to the book that provides a bibliography of articles and books authored by Breck. The 8 1/2 x 11 book has 188 pages of text and an additional 44 color pages of Breck's paintings.

Four of the organizations with which Breck had especially close ties, including our Chapter, have agreed to sponsor the publication of his autobiography with a \$2,000 donation. The Breckenridge Chapter Board of Directors believes most or all of our sponsorship will be provided through a special fund raiser. For a \$100 contribution donors will receive a special hard cover limited edition of the Breckenridge autobiography. Only 25 of these hard cover books will be available to the Breckenridge Chapter. It is

possible the books would be presented at a special book signing event at the Chapter House attended by some of the Breckenridge family, John Moriarty and Dr. Susan Weller (present curator of the Bell Museum and who, along with Barbara Franklin, wrote a foreword to the book). The book is expected to be published in late fall or early winter. A soft cover version of the book will be available for approximately \$20.

At our July 23rd meeting we asked those interested in purchasing one of the limited edition hard cover Breckenridge autobiographies to indicate their interest by placing their name on a list. At this time fifteen of the 25 copies have been spoken for. If you're interested in placing your name on this list please contact me via email (jjarnold@Q.com) or by phone (763 560 8972). We expect to collect the \$100 donations this fall. If we fail to sell enough copies to members we'll then reach out to others in the community. We expect that a considerable portion of the special edition hardcover purchase could be considered a tax deduction (a detail that needs clarification).

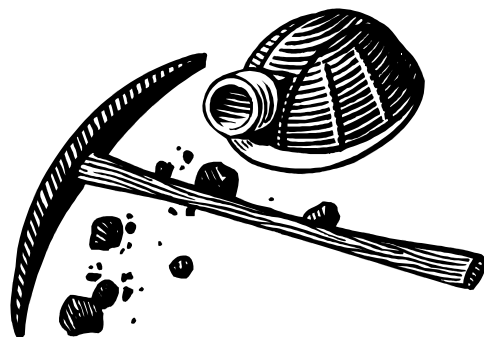
Sulfide Mining in Minnesota – Position Statement

There are new kinds of mines being proposed for Northern Minnesota near the Boundary Waters Canoe Area Wilderness and Voyager National Park. These new mines are different from long established iron ore mines that Minnesota has had over the years. They contain significant deposits of sulfide minerals including copper, nickel, cobalt, gold, and platinum. The sulfur in the mines, waste rock, and mine tailings could leach off into surface and ground water, creating yellow and red streams with toxic heavy metals, sulfates, and mercury. Water that contains heavy metals, sulfuric acid, and mercury, kills fish, birds, other aquatic life, and can impact human health. The watershed for the proposed sulfide mines include the Kawishiwi River, which flows into the Boundary Waters Wilderness, and the St. Louis River, which flows into Lake Superior. The toxic runoff caused by sulfide mining is called Acid Mine Drainage (AMD). AMD impacts aquatic resources and wetlands, contaminates groundwater, raises water treatment costs, and damages concrete and metal structures. There are already several thousand miles of streams impacted by AMD within the United States, from metal and coal mining. The economic losses due to AMD in other parts of the country on fisheries and recreational use amount to hundreds of millions of dollars' annually. AMD can render a water source unsuitable for drinking by humans and livestock. Because of the potential for Acid Mine Drainage, sulfide mines require special treatment systems to ensure that acidic water is not discharged. AMD treatment systems must be in place for the life of a mines operation and continue treatment even after the mine is closed. Water treatment at reclaimed mining sites is complicated by changing levels of ground water and fluctuating rainfall levels over decades and centuries. If movement of acidic water is not contained within an impermeable barrier (e.g. using pipes, plastic sheets, earthen/clay dams etc.) the acidic water flows into the surface and underlying groundwater system. Once the acidic water enters the groundwater system, the detrimental effects on flora and fauna becomes widespread. Containment and treatment of affected groundwater is difficult, if not impossible. Funding for long-term treatment of acidic waters and long-term responsibility and liability for environmental protection is ongoing. Mining companies and water treatment operators are unlikely to be permanent. There are many examples of bankruptcy in the industry, with operators abandoning properties, consequently requiring public money to clean up, becoming EPA Superfund sites. Unlike dry Western states, Minnesota is rich in high quality water resources

that are especially vulnerable and are a great part of Minnesota's outdoor heritage for anglers, canoeists, duck hunters and of course wildlife. Our neighbors in Wisconsin have a moratorium on mining metallic sulfide ores written into law. In effect, the Wisconsin law says "Industry can mine metallic sulfide ores in Wisconsin when it can show one mine in the United States or Canada that has operated and been closed for ten years without significant damage to its watershed." The Izaak Walton League of America has a long history of fighting for, protecting, and preserving Minnesota's North Woods and wildlife, and has always been at the forefront in water quality protection. The Izaak Walton League was instrumental in the effort to create the Boundary Waters Canoe Area Wilderness, and continues with efforts to protect the BWCAW and its watershed from endeavors that may degrade its pristine quality.

Therefore: The Minnesota Division of the Izaak Walton League of America at convention, April 25, 2009, Detroit Lakes, Minnesota, supports legislation which bans the use of perpetual treatment systems for sulfide mine tailings and the discharged water that is produced by sulfide mines. The Minnesota Division of the Izaak Walton League of America further urges Minnesota not to permit any new mines that require ongoing water treatment after the mine was reclaimed. In the event that the state of Minnesota does permit such a mine, the state must require financial assurance from mine operators "up front" for remediation and restoration that may be required to mitigate all impacts resulting from mining operations.

**ADD ADJACENT PARCELS OF LAND TO
THE BOUNDARY WATERS
CANOE AREA WILDERNESS**

The year 2008 marked the 30th anniversary of Congressional passage of the BWCAW Act (P.L. 95-495). The Minnesota Division and the national Izaak Walton League have been actively involved in protecting this forested wilderness since 1926 when Ernest Oberholtzer and the League battled timber and waterpower interests for one of the first wilderness preservation efforts in the country.

Today it has become one of America's top ten vacation destinations hosting over 200,000 visitors each year while remaining home habitat to black bears, moose, timber wolves, pine martens, beavers, lynx and over 150 species of nesting birds. In addition to the boreal forest cover, it contains over 1,000 lakes, hundreds of small ponds, creeks and rivers, 1100 miles of canoe routes and thousands of miles of shoreline.

Those first efforts, in which the IWLA has been so heavily invested, have secured just over one million acres of roadless canoe country wilderness. It is very important that we now add to the BWCAW nineteen (19) contiguous parcels (chart enclosed) totaling approximately 49,000 acres. These are small pristine areas that adjoin the BWCAW. There are occasional, small incursions of private land but approximately 90 percent of it is currently owned by the United States Forest Service.

Rising population levels and economic development are putting continued pressure on natural resources and open spaces. Increasing activity by extractive industries is a constant threat to our resources and the more than 200,000 people who seek restoration of body and spirit each year by visiting true wilderness will be well served by our preservation efforts now. An attempt was made in 2005 by the Breckenridge Chapter of Brooklyn Park to make an even larger inclusion of wilderness lands in Northeastern Minnesota into the BWCAW, but it failed to gain support at the national level. We have scaled back our acreage request by about half in hopes that the National IWLA will accept our proposal, help re-investigate our plan to increase and preserve this only lakeland wilderness in the country and hope that the new administration will look more favorably on these efforts to enlarge this precious resource.

Therefore be it resolved the Minnesota Division of the Izaak Walton League of America in convention in

April 2009, seeks to permanently protect the pristine water, air and forest habitat contained in these nearly 49,000 roadless acres within Minnesota's Superior National Forest, and make them contiguous with current BWCAW boundaries. We urge the Federal Government to support and facilitate this addition to the BWCAW.

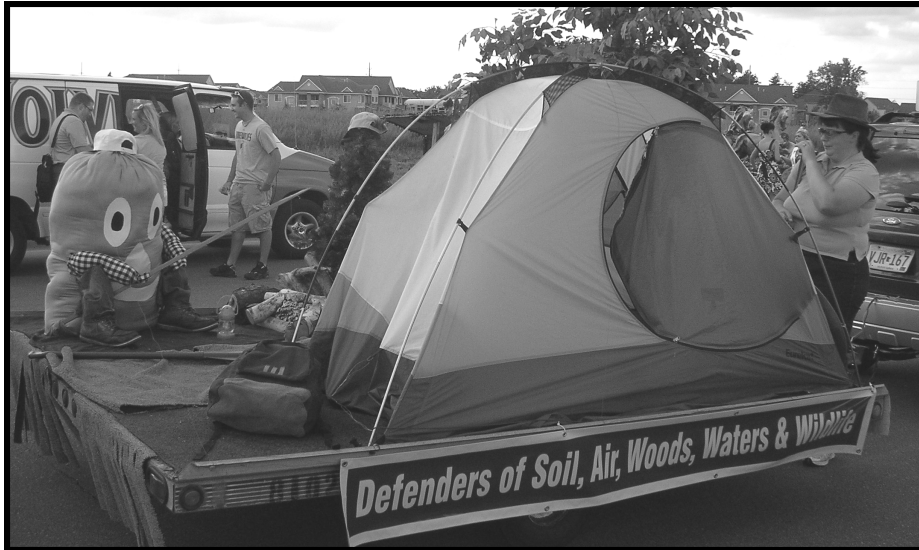

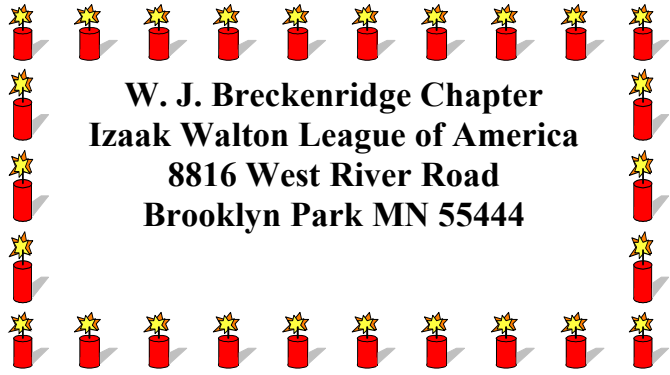

Dawn Rust built a great float to represent our chapter.



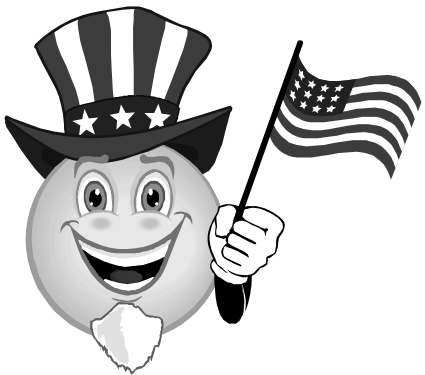
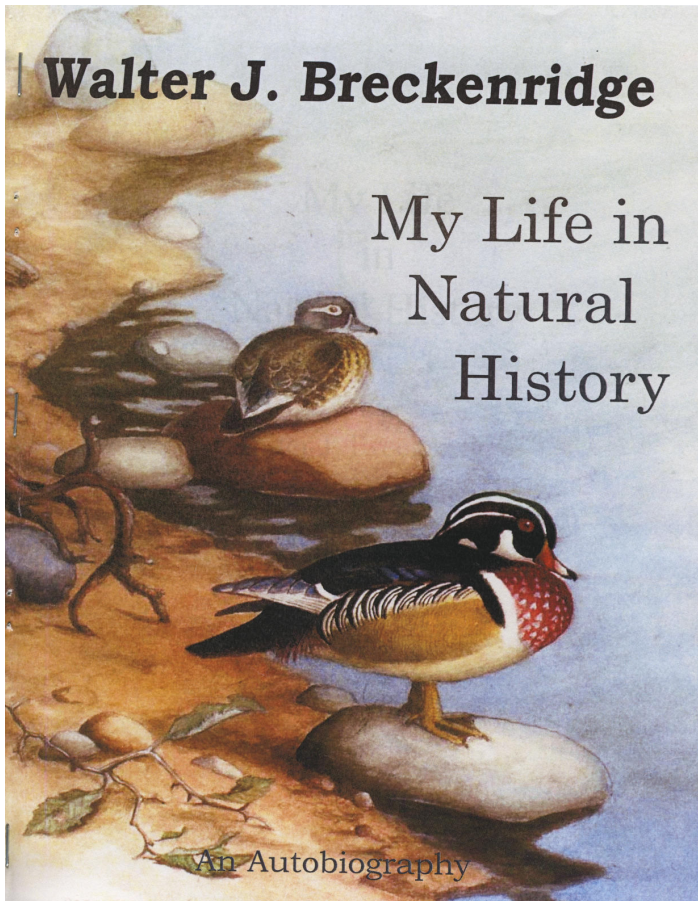
